New Business:

C. **New Ordinance:** TO REQUIRE ANNUAL INSPECTIONS OF MASSAGE, BODYWORK AND SOMATIC THERAPY BUSINESS AS SET FORTH IN CHAPTER 170 OF THE BOROUGH CODE AND DIRECTING THE HEALTH OFFICER TO PERFORM COMPLIANCE INSPECTIONS FOR BUSINESSES, PUBLIC SPACES AND SPECIAL EVENTS DURING THE COVID-19 PANDEMIC.

Board of Health members reviewed the proposed Ordinance from the Governing Body. Discussion ensued over the Ordinance. The Bernards Twp Board of Health attorney felt that "elected services" such as inspections of massage parlors would have to be agreed upon services before entering into contract. The earliest they believed it could go into effect would be 2022. Board of Health attorney agreed with Bernards Twp. The Board would like to review the use of municipal property and event application. The Board plans on discussing the fees this will involve at the next meeting.
