AN ORDINANCE OF THE CHESTER BOROUGH BOARD OF HEALTH, MORRIS COUNTY, STATE OF NEW JERSEY, AMENDING THE CODE OF THE BOROUGH OF CHESTER, PART III (BOARD OF HEALTH), CHAPTER 235 (GENERAL PROVISIONS) SUB-SECTION 235-1 (INSPECTIONS) TO REQUIRE ANNUAL INSPECTIONS OF MASSAGE, BODYWORK AND SOMATIC THERAPY BUSINESS AS SET FORTH IN CHAPTER 170 OF THE BOROUGH CODE AND DIRECTING THE HEALTH OFFICER TO PERFORM COMPLIANCE INSPECTIONS FOR BUSINESSES, PUBLIC SPACES AND SPECIAL EVENTS DURING THE COVID-19 PANDEMIC.
