Roll Call: Kelli Kovacevic, Betsy Fila, Michael Ferrone representing the Commission. Sandee Moroso Fela, Recreation Director. Dan Hartman and Chris Rapseik, guests.

Call to Order:

Sunshine Law Statement read.

Minutes: 6/26/18 minutes approved.

Guests/Public Input: Chris Rapseik, Chester, representing concerns of tennis players. 1. Tape was buckling and was a safety concerns. Now more permanent tape is being used and there is no buckling. 2. Recommended that we turn one court into a permanent 2 pickleball courts. Correction to minutes 9/24/18. When asked what the optimal solution would be for the borough courts, Chris suggested to provide separate dedicated facilities for Pickleball and to not reduce current tennis facilities.

Dan Hartman, Chester, Pickleball update and concerns. 1. This is a prototype for community interest in Pickleball. 2. Evaluate participation results at the end of fall. 3. Trial was to include using non-permanent lines on tennis courts. 4. Dan urged cooperation between Pickleball and Tennis players.

Commission stated that this is an approved prototype for community interest in Pickleball. We stressed our appreciation for Dan Hartman's commitment and volunteer time to tape courts and coordinate times on the courts. Dan found and is using a tape that is not buckling, eliminating the safety concerns. The

Commission will evaluate interest and recommendations after the fall court-sport season ends. Cooperation between all users of the Borough courts is encouraged.
