TREE REMOVAL/TREE PLANTING

Four on Elm Street, eight from the recent removals and tentatively six from the trees removed by JCP&L's contractors. At this time some stumps on Hillside Road and Pleasant Hill Road will remain. The list will be updated this spring and locations confirmed. STC plans to again ask the DPW to remove all stumps.
